2.2 Any person or combination of persons who is interested in purchasing specified residential property(ies) and who are present (whether personally or through attorney(s) personally) in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale of the First Date of Sale. Each such person or (as the case may be) combination of persons will be referred to as a “Participant”.

2.3 The Participants will be grouped into the two following groups:

(i) “First Round Participants”: Participants who indicate an intention to purchase one or more Same Floor 2 Properties Combinations; and  
「首輪參與人」：表明意欲購買一個或以上同層雙物業組合之參與人；及

(ii) “Second Round Participants”: Participants who do not indicate an intention to purchase one or more Same Floor 2 Properties Combinations.

2.4 (i) A person may only be included in at most one First Round Participant. For the purpose of illustration: (1) if a person A is a First Round Participant, that person A together with another person B may not form another First Round Participant; (2) if a Person A together with another person B comprise a First Round Participant (subject to paragraph 2.4(ii) below), that Person A alone and that Person B alone may not request to be taken as another First Round Participant.

(ii) If a First Round Participant comprises more than one person, each such person comprising that First Round Participant must be an “Immediate Family Member” of each other person(s) comprising that First Round Participant.

(iii) A person may only be included in at most one Second Round Participant. For the purpose of illustration: (1) if a person A is a Second Round Participant, that person A together with another person B may not form another Second Round Participant; (2) if a Person A together with another person B comprise a Second Round Participant, that Person A alone and that Person B alone may not request to be taken as another Second Round Participant.

(iv) Subject to paragraphs 2.4(i), (ii) and (iii) above, the same person may be included in a

First Round Participant and also a Second Round Participant. For the purpose of illustration: (1) if a person A is a First Round Participant, that person A alone could be or together with another person B may form a Second Round Participant; (2) if a Person A together with another person B comprise a First Round Participant (subject to paragraph 2.4(ii) above), they together may form a Second Round Participant, or alternatively, that person A alone could be a Second Round Participant and that person B alone could also be another Second Round Participant.

- 2.5 Higher priorities of selection of specified residential properties will be given to the First Round Participants. Balloting will be used to determine the order of priority of selection of specified residential properties among the First Round Participants (the “First Round Balloting”). The First Round Participants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the result of the First Round Balloting. A First Round Participant must select one Same Floor 2 Properties Combination, with or without any other specified residential property. If a First Round Participant fails to make such a selection for whatever reason (whether or not because there remains no Same Floor 2 Properties Combination for selection), that First Round Participant will cease to be eligible to select any specified residential property according to the result of First Round Balloting.

首輪參與人將獲較優先之揀選指明住宅物業次序。首輪參與人之間揀選指明住宅物業之優先次序將以抽籤（「首輪抽籤」）決定。首輪參與人根據首輪抽籤結果分配之順序揀選當時仍可供選擇的指明住宅物業。首輪參與人須揀選一個同層雙物業組合，不論是否同時揀選其他任何指明住宅物業。若首輪參與人因任何原因（不論是否因已無同層雙物業組合供揀選）未能作出如此揀選，該首輪參與人即失去就首輪抽籤結果揀選任何指明住宅物業之資格。

- 2.6 Where a First Round Participant selects any specified residential property under paragraph 2.5 above, the purchaser of that specified residential property shall only be:

- (iv) that First Round Participant together with one or more “Immediate Family Members” of that First Round Participant (or any person comprising that First Round Participant) whom that First Round Participant requests the Vendor on spot to add as joint purchaser(s); or

- (v) one or more persons comprising that First Round Participant (each a “Remaining Participant”) together with one or more “Immediate Family Members” of any Remaining Participant whom any Remaining Participant requests the Vendor on spot to add as joint purchaser(s).

- 2.7 Balloting will be used to determine the order of priority of selection of specified residential properties among the Second Round Participants (the “Second Round Balloting”). After the completion of the selection of specified residential properties under paragraph 2.5 above, the Second Round Participants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the result of the Second Round Balloting Provided That the maximum number of Flat B of Tower 3C that a Second Round Participant may select is two.

次輪參與人之間揀選指明住宅物業之優先次序將以抽籤（「次輪抽籤」）決定。完成上文第2.5段下指明住宅物業揀選程序後，次輪參與人根據次輪抽籤結果分配之順序揀選當時仍可供選擇的指明住宅物業，唯一名次輪參與人可揀選之第3C座B單位之數目為最多兩個。

- 2.8 Where a Second Round Participant selects any specified residential property under paragraph 2.7 above, the purchaser of that specified residential property shall only be that Second Round Participant.

3. On the day following the First Date of Sale and thereafter:

First come First served. Persons interested in purchasing (or their attorneys) must personally attend the designated venue. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

- (a) Prospective purchasers will be offered to view the selected specified residential property(ies), or comparable residential property(ies) if it is not reasonably practicable for such specified residential property(ies) to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.
